Nominations, which must be in writing and comply with the registered rules of the Organisation, may be made at any time from 12:00pm Australian Eastern Standard Time (AEST) 30/09/2022.

A nomination form is available for electronic completion on the AEC Portal, www.aec.gov.au/ieb/. However, the nomination form must then be lodged in accordance with the Organisation's rules (see below).

Additional forms are available from the Returning Officer.

Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

Nominations must reach the Returning Officer via the lodgement method(s) stipulated below **not later than** 12:00pm Australian Eastern Standard Time (AEST) **on** 28/10/2022.

How to lodge nominations, nominations must be lodged via the following method(s):

By Email: A properly completed nomination form including all necessary signatures and attachments may be scanned and submitted as a pdf file to IEBnominations@aec.gov.au

PLEASE NOTE:

1. Emails to the AEC inbox that appear to be spam may be blocked. It is the responsibility of senders to ensure that their email reaches the AEC before the deadline for nominations.
2. In order to be able to be received by the AEC, emails (including attachments) should be no greater than 6 MB in size.

Withdrawing Nominations

Nominations cannot be withdrawn after 12:00pm Australian Eastern Standard Time (AEST) on 04/11/2022.

Candidate Statements

Candidates may submit a statement to express their views to members of the Union, to a maximum of 250 words, to be included with ballot material. Statements to be sent as word document and must be received by the Returning Officer by 12:00pm (Australian Eastern Standard Time (AEST)) on 28/10/2022.

Voting Period

The ballot, if required, will open on 11/11/2022 and close at 10:00am Australian Eastern Standard Time (AEST) on 16/12/2022.

Scrutineers

Each candidate may have one scrutineer who must be appointed in writing and signed by the candidate. A form is available from the Returning Officer for the purposes of appointing Scrutineers.
